



Utilities, Inc. of Georgia Irrigation Audit Rebate Program

APPLICATION

Irrigation accounts for more than 50% of residential potable water use. Water conservation has never been more important as has the reduction of our reliance on the Floridan Aquifer. In an effort to encourage water conservation and a reduction in water use across Skidaway Island, Utilities, Inc. has initiated an *Irrigation Audit Rebate Program*. Through this rebate program, the following should be accomplished during the irrigation audit (but not limited to): detect any leaks, repair any broken irrigation heads, maintain a consistent watering distribution amongst turfed areas, re-adjust irrigation zones, evaluate rain sensors, etc.

Process:

1. Applicant must have a Utilities, Inc. of Georgia account whose property exists within The Landings on Skidaway Island, Savannah, Georgia. (Note: Applicants with a functioning shallow well will not qualify.)
2. Applicant must submit a formal request in writing to irrigationauditprogram@gmail.com to determine program availability as spacing for the program is limited to 30 applicants.
3. Applicant must have an audit performed by the following approved landscape contractor/vendors:
 - **Landscape Arts** – 912-667-1303
 - **Oasis Irrigation and Lighting** – 912-313-1110
 - **Coastal Rainmaker** – 770-668-4918
4. Audit must be under the approved amount of \$200.00. Should any improvements be required and/or recommended by the approved vendor, applicant is encouraged to make the necessary changes. Should the changes not be made, applicant will only be eligible for partial reimbursement at the discretion of Utilities, Inc.
5. Once the audit has been completed, applicant is responsible for submission of vendor invoice and completed application to Utilities, Inc. at irrigationauditprogram@gmail.com. Please note that any repairs and/or upgrades to the applicant's irrigation system above and beyond the eligible agreed upon amount (between applicant and Utilities, Inc.) will be at the sole expense of the applicant. As a reminder, this audit rebate program is only for the pre-approved amount identified above.
6. Applicant must submit a copy of the completed application and vendor invoice within fourteen (14) days of audit completion. If said documents are not received within this timeframe, applicant will be ineligible for program and will be responsible for payment to vendor. Likewise, should the applicant choose a vendor not listed above, applicant will be ineligible for program reimbursement.
7. Once Utilities, Inc. has received the completed application and a copy of the vendor's invoice, the approved vendor will receive reimbursement within 14-21 days.
8. Please note that this program is limited to the first 30 applicants and is based on a first-come-first serve basis.
